The effects over an interview including the Head concerning the Food Security Service, Mr. Arifin about Thursday, January 4, 2018 he said:

"For community empowerment efforts in processing sago or enbal into quality goods, trainings are conducted to improve skills and innovations in processing enbal or sago. For example, now there are innovations from processed enbal or sago products such as crispy enbal, chocolate and cheese enbal, kokis enbal and enbal sticks, there are also suggestions and infrastructure assistance in the production of enbal from relevant agencies "

- The implementation of a social security system for community members in need, especially the poor and neglected children, where the Southeast Maluku District Food Security Service also seeks to increase HDI with one of its programs, namely the development of island food self-sufficient areas in the context of empowering the poor.
- The distribution of ownership of material capital is relatively evenly distributed among members of the community. The Food Security Agency strengthened the Community Food Distribution Institution (LDPM) in 2016 which was supported by the "distribution system development" program, implemented through the "Strengthening Community Food Distribution Institution (LDPM)" activity. From the implementation of this activity, Rp. 5,000,000 for the development of the marketing business of processed food products for 2 marketing groups of processed food products, namely the Maren Group (Ohoi Ohoirenan) and the Prosperous Group (Ohoi Debut).
- The implementation of national education free of charge for every member of the community. The average length of schooling (MYS) in Southeast Maluku Regency can be seen in table 4.4 in 2017 about 9 years of education where the cost of education is still the main obstacle when compared to the Expected Length of School (EYS) which reaches 12 years or equivalent to D3 very much compared to expectations. The Southeast Maluku Regency Government has also not been able to provide free education to its people.
- -Guaranteed independence of every member of the community to establish and become members of economic unions. The level of achievement of performance indicators for the number of policies on food security affairs in 2016 reached the target of 100% as seen from table 4.3, where the realization of the achievements of 3 policies realization as of December 31, 2016 include:
 - Southeast Maluku Regent Decree Number 314.c of 2016 dated 15, February 2016 concerning the Establishment of the Southeast Maluku District Food Security Council for Fiscal Year 2016;
 - Southeast Maluku Regent's Decree 2015 dated January 16, 2016 concerning the Establishment of Assistance to Community Food Distribution Institutions (LDPM) Food Security Agency of Southeast Maluku Regency for Fiscal Year 2016; &
 - Decree of the Head of the Southeast Maluku Regency Food Security Agency for Fiscal Year 2016 Number 18.c
 Year 2016 dated November 15, 2016 concerning the Determination of Farmer Groups as Recipients of Institutional Strengthening Assistance for Community Food Distribution (LDPM) for Fiscal Year 2016.

5. CONCLUSION

Conclusion

Some conclusions that can be drawn are:

- Building food self-sufficiency through diversification of staple foods based on local food (enbal) is a way of procuring more than one type of goods/commodity that is consumed. Food diversification is aimed at reducing dependence on certain types of food, such as rice, which will increase consumption in line with the increase in the population of Southeast Maluku Regency and increase the amount of production and consumption of enbal or sago as a complementary food for rice.

The implementation of this change project is very beneficial for the availability, consumption and distribution of local staple food, so that the potential of local food in an area can be developed as a source of income for the community as well as a source of food in the area and the community can live a healthy, strong, active and productive life with local food.

Suggestion

Based on the results of the research described above, to achieve food self-sufficiency through food diversification based on local food (enbal) in Southeast Maluku Regency:

- Improving the human resource capacity of the apparatus and facilities, knowledge, skills and business insights for local food producers (enbal).
- It is necessary to facilitate and provide guidance to strengthen Small and Medium Enterprises (SMEs) and wholesalers in order to accommodate these local food products so that the farmers and producers of green rice are more fluent in terms of production and marketing.
- Distribution of government credit schemes by banking financial institutions to local staple food producers within the framework of strengthening capital
- It is necessary to do alternative policies that are able to create food self-sufficiency through diversification of staple foods based on local food.
